Hi Andrea -

I'll just chime in with a couple of thoughts. Your Chair and the SB's concerns are obviously not uncommon. As Anthony noted, no tobacco retailers have closed down in Brookline where this law has worked to eliminate sales to young people as they turn 21 and beyond and protect them from addiction to nicotine (and the health impacts and tremendous costs involved).

Because this policy only applies to folks who have yet to be old enough to buy tobacco, there is not a large existing demand that would motivate them to drive to other towns to start buying tobacco products. But the policy would, by design, deny Belchertown tobacco retailers the opportunity to get new tobacco customers from the ranks of youth you are about to turn 21. Those retailers would not, however, lose any existing customers who could all continue to buy tobacco. Nicotine Free Generation has a very tiny impact on retailers each year over a long period of time and puts communities that adopt it on a path to eventually be tobacco free.

It is not necessarily the right policy for everyone or every place. But if the long term health outcomes for the town are a priority, NFG will make it possible to gradually phase out the sale of the most harmful consumer product sold in Belchertown with minimal disruption to tobacco permit holders.

Restaurant and bar owners argued passionately and sincerely that banning smoking would put them out of business. There was resistance to raising the minimum tobacco

sales age and a huge uproar opposing the ban on flavored tobacco sales. Yet, restaurants, bars, and retailers have adapted to the regulatory environment and remain in business. Most of the opposition is created by the tobacco industry and their retail trade associations because, over the very long haul, these policies will work to dramatically shrink their industry and, with it, the morbidity and mortality they cause which is currently just under a half million annual premature deaths in the U.S.
