Hi Alexy,

Sorry, I misunderstood your earlier question. I thought you were referring to the supervising MD when you asked about the consultant position.

We are definitely going ahead with the plan to create positions for one or two associate BOH members (probably two). We're drafting a by-law about it now. When we and Town Counsel are done with that, the Warrant Committee will review it. Then it goes on the Warrant for the May meeting.

Thanks very much for sending the post to SPAN. I just looked at its website. It seems like the perfect group to hear about the proposed regulation.

By the way, at its meeting yesterday, the BOS discussed a proposal to put a Keno monitor in the Dover Market. They postponed action on it because they need more information before making a decision. I'm going to talk with Jason about it today. The BOH has no jurisdiction over gaming, but it can certainly express its opinion.
