To the Dover BOH, Board of Selectmen, and Administrator Blanchard:

Please do not enact a Generational Tobacco & Nicotine Ban. It is prohibition by stealth.

- 1) Immigrants of color own most of the stores that sell tobacco & nicotine products. Such a prohibition might not close their businesses, but it would significantly hurt & devalue them.
- 2) Although proponents say this ban is for the young, the CDC reports that the teenage smoking rate is at a 25-year low. According to the FDA, the youth vaping rate is at a 10-year low & their use of nicotine pouches "remains low." If the tobacco industry is trying to attract the young, it is not succeeding. A Generational Tobacco & Nicotine Ban does not affect youth. It limits the autonomy of adults.
- 3) Massachusetts residents 21 & over are deemed competent to use their judgment when it comes to alcohol and marijuana--both intoxicants. They are at least equally competent, and do not need to be prohibited from, making their own decisions regarding tobacco & nicotine. Neither of which impairs judgment or compromises driving ability.
