Exploring the FPHS Framework: Foundational Capabilities (FC)

The Foundational Public Health Services (FPHS) Framework comprises **8 Foundational Capabilities, which include the required knowledge, skills, and abilities for successful FPHS implementation**. These capabilities encompass the cross-cutting skills or functional capacities necessary to support and enhance the Foundational Areas. Foundational Capabilities include Assessment & Surveillance, Community Partnership Development, Equity, Organizational Competencies, Policy Development & Support, Accountability & Performance Management, Emergency Preparedness & Response, and Communications.

The Foundational Capabilities form the base of the FPHS Framework and emphasize the importance of building a solid infrastructure to facilitate FPHS implementation. They are crucial for local public health system functionality and support widespread efforts towards promoting community health, well-being, and equitable health outcomes.

Foundational Capabilities include essential skills such as the ability to:

- Provide timely, statewide, and locally relevant and accurate information
- Maintain an organization-wide culture of quality and use quality improvement tools and methods
- Develop, exercise, and maintain preparedness and response strategies and plans
- Appropriately tailor communications and communications mechanisms for various diverse audiences
- Manage human resource functions, including recruitment, retention, and succession planning

Each capability is essential to the work of local public health, and they will be tailored to Massachusetts through the FPHS Relevant Description Process to ensure they are applicable within the state's context.

In the May 23 *Pulse* Newsletter, we will explore the next component of the FPHS Framework—the 5 Foundational Areas—to understand how they form the essential framework for a comprehensive public health system.

Registry of Vital Records and Statistics (RVRS) to Launch New Records Collection System - MAVRIC

RVRS is tracking for a July 2024 launch of the electronic death registration process of the Massachusetts Vital Records Information Collaborative ([MAVRIC](#)) system. MAVRIC will be implemented in phases, starting with the electronic death registrations. Birth and marriage registration in MAVRIC will follow in 2025.
