TRAIN MA - LPHI Course Record Transfer Update

Since the sunset of the Local Public Health Institute (LPHI) website on April 1, 2024, OLRH has been dedicated to the seamless transfer of course completion records from LPHI to TRAIN Massachusetts (TRAIN MA). Our focus has been to ensure the accuracy and security of each user's course record transfer. To date, we have successfully transferred the course completion records for more than 425 registered TRAIN MA users.

Strategies for Local and Regional Public Health

With the fourth largest internal migration in the country in 2020, Barnstable County has successfully maintained high vaccination coverage. The Barnstable County Department of Health and Environment, a combination county-level health department and a shared service arrangement (SSA), has largely contributed to the county's high vaccination rates.

The Greater Boston Food Bank released their fourth annual statewide food equity and access report. This report highlights research on the state of food insecurity, equity, and access to critical nutrition programs in Massachusetts during 2023.
