Thank you for another great meeting for the Environmental Health Working Group!
Attached are the meeting notes.

I am also attaching the list of Performance Standards that were commonly labeled as N/A (Not Applicable) by each town. Many of them may genuinely be N/A for your town at this moment, but some of them could happen at any time and we would like to evaluate if your department would have resources to address them if they came up.
