RCAP Solutions Partnering with Several Community-Based Organizations to Expand RAFT Program Access Throughout Central Massachusetts

Residential Assistance for Families in Transition (RAFT) is a state-funded financial assistance program which helps keep families safely housed.

RCAP Solutions is proud to announce a partnership with [Valuing Our Children](#), the [Spanish American Center](#), and the [Worcester Community Action Council](#), which expands access to the Residential Assistance for Families in Transition (RAFT) program for individuals and families throughout Central Massachusetts.

Thanks to this partnership with these community-based organizations (CBOs), clients who are unable to access or complete an online application may contact RCAP Solutions or one of

these CBOs directly to schedule an appointment. During the appointment, clients will be guided through the application process. These appointments can be conducted in-person or virtually. **For more information, [click here](#).**

RCAP Solutions administers RAFT funds and provides application assistance to residents throughout Central Massachusetts, except for those living in the city of Worcester. Effective immediately, residents of the city of Worcester who apply for the RAFT program will have their application processed by the Central Massachusetts Housing Alliance (see our [RAFT Service Area Map](#)).

This change was made based on the Healey-Driscoll Administration's decision to establish a standalone secretariat focused on housing.

Heidi and Zoe's Story: Using Funds From the Home Modification Loan Program (HMLP) to Improve a Family Member's Quality of Life

HMLP can benefit anyone in the house who has a disability or mobility impairment; the homeowner themselves, their child, or an elderly family member.

This testimonial features Heidi and her daughter Zoe. Diagnosed with Cerebral Palsy and Autism Spectrum, Zoe has limited mobility and requires assistance for basic living functions. Using stairs and getting into the bathtub proved to be a challenge for both Zoe and her parents – who she relies on to assist her.

The [Home Modification Loan Program \(HMLP\)](#) provided funds for a ramp to the front entrance of her home, a walk-in shower with grab bars, and several other modifications which allow Zoe to traverse her house with ease and

provide her with
increased independence.

Coalition for Safe Drinking Water Hosts Informational Briefing at the Massachusetts State House

The [*Coalition for Safe Drinking Water*](#) is a group of diverse individuals and organizations advocating for equitable access to safe drinking water for private well owners across Massachusetts.

Earlier in May, the [*Coalition for Safe Drinking Water*](#) hosted an informational briefing for Massachusetts legislators and their staff. The event highlighted *An Act Promoting Drinking Water Quality for All* ([S.482/H.902](#)), which aims to provide drinking water protections for the 500,000+ Massachusetts residents who rely on private wells.

Joined by The Health Foundation of Central Massachusetts, and lead bill sponsors, Senator Jamie Eldridge, State Representative Dan Sena, and

Representative Smitty Pignatelli, the event was a great success and featured testimonials from health experts, private well homeowners, and advocates.

Solid Waste Case Study: Municipality of Comerío, Puerto Rico

After the hit of hurricanes Irma and Maria in 2017, the high

volume of debris and waste stressed the limited capacity of Comerío's municipality to deal with it. They depend on a small Transfer Station (TS) for the management of the materials and waste to be disposed.

A Materials Recovery Facility (MRF) with noticeable challenges was part of the strategy but it ends in the closing of the program in 2019, adding significant pressure to their TS and incrementing the cost of the operation running over its capacity. The process to reopen the MRF and reduce the waste, and the operational cost required an operator with technical knowledge about the materials but also about facilities, development, and permits.
