MassDEP Reduce, Reuse, Repair Micro-Grant

The [Reduce, Reuse, Repair Micro-Grant](#) provides grant awards from \$3,000 - \$10,000 to eligible businesses, non-profits, regional authorities, municipalities, and schools/colleges for short-term waste reduction projects (defined as projects lasting ≤ 1 year). To qualify, projects must focus on reducing waste in Massachusetts by extending the life of products **through donation, sharing, rescue, reuse and/or repair**.

Composting and recycling projects are not eligible for this grant.

Application deadline: Thursday, May 15, by 5 p.m.

Municipal ADA Improvement Grant

The Massachusetts Office on Disability [FY26 Municipal ADA Grant](#) is open for applications! The grant provides reimbursement funding to Massachusetts cities and towns to improve accessibility for people with disabilities.

These grants provide reimbursement funding for:

- * Updating a municipality's ADA Self Evaluation and Transition plans, or
- * Making capital improvements that improve access or remove barriers in municipal programs, services, and facilities.

The purpose of this [Request for Responses \(RFR\)](#) is to establish a pre-qualified list of approved vendors, namely **local and regional public health entities**, to be eligible for potential to receive future funding from the Department of Public Health (DPH).

All municipalities and/or regional health districts are strongly encouraged to apply as many future DPH grants will be distributed through this municipal master services agreement (MSA). **NOTE:** PHE lead grantees are already in the MSA and do not need to apply.
