NACCHO: New Communications Planning Guide

A new [Communications Planning Guide for Local Health Departments](#) has been designed for local health department staff who are tasked with communicating specific messages to the public. The guide provides a basic framework to use, including questions to consider when developing communications and evaluation strategies. It also includes considerations for how local health department professionals can incorporate health equity, social justice, and accessibility considerations, including health literacy, into their work.

DPH Announces Additional Human Cases of WNV and EEE in Mass.

DPH [announced](#) the fourth human case of Eastern equine encephalitis (EEE) in the state this year, on Monday. The case is a man in his 50s with exposure in an area in Middlesex County at high risk for EEE.

DPH also [announced](#) three additional human cases of West Nile virus (WNV). All three individuals are in their 60s. One is a woman who was exposed in southern Bristol County. The second is a man in his 60s who was exposed in Suffolk County in an area already at high risk. The third is a man who was exposed in Barnstable County.
