Hi, Anita,

In DC, our city council passed a flavored tobacco ban about a year and a half ago that we just started implementing last fall. You can see the full bill here (lms.dccouncil.gov/downloads/LIMS/46321/Meeting2/... and it prohibits the sale of all flavored tobacco products (including vapes, etc.). It also doesn't allow the sale of any electronic smoking devices within a quarter mile of any high school or middle school.

Also, on the state level there's a tobacco flavor ban bill, which would greatly impact vape shop inventory.
