For this funding opportunity, NACCHO will award LHDs in the amount of \$75,000 or \$150,000 based on the scope of work. Applications for New Leadership Enhancement Opportunity Now Open

Applications are now available for the 2023-24 cohort of Public Health Regenerative Leadership Synergy (PHEARLESS), a new leadership enhancement opportunity based on the principles of regenerative leadership. PHEARLESS will support up to 150 local health departments, each with two community leaders and two public health leaders in the same community, in developing the mindset and systems power structures and processes to facilitate the design of equitable, health-promoting communities.
