Hey Ryan,

Good to know. It feels like a low-grade influenza. Thankfully I got the vaccine so it's not debilitating. I've taken a look at your draft regulations and they look fine to me. The website also has everything folks will need. Regarding the cessation. That feels like it'll be an evergreen project where the Health Department will build it out as NFG progresses. Right now there will be virtually no cessation burdens, but that burden will grow in future years—exponentially more if the state adopts a similar policy for all residents in the Commonwealth.

I'm genuinely loving my work with you all. You're a great team, and we're getting a surprising amount of work done with my limited hours. This is just more evidence for the Mayor to consider a full time or at least part time community health worker in next year's budget.

And who knows, if a vacancy still exists on the Board of Health this summer, I'll apply and we can still work together.
