I hope all is well.

Attached Excel sheets are report from POST database on Education/Inspection visits and Compliance checks in the Town of Hopkinton.

Education/Inspections visits were conducted after receiving the attested BOH updated Tobacco Sale restriction regulations that include adoption of NFG policy and prohibition of Nicotine Pouches to Adult Only Retail Tobacco Stores (AORTS).

100% Compliance was documented in all 7 tobacco permitted stores in the Town of Hopkinton on 105 CMR 665.045 (A) - Sale to minor.

Nicotine Free Generation policy and Prohibition of Nicotine pouches policy are implemented in the Town of Hopkinton as of July 1, 2025. The Education / inspection visits on the same were conducted in July 10, 2025 after receiving the attested Hopkinton BOH Tobacco Sale restriction regulation.

Enforcement on the above two policies shall be done in discussion with the Health Director and BOH in FY26.
