Good afternoon Nidia,

- 1) It looks like one to three people might be present for public comment. We will instruct Nasiba to provide them 3:00 minutes each.
- 2) Maureen or one of the other NFG representatives will provide their 10 to 15 minute presentation. They will ask if there are any questions. They will provide their contact information.

- 5) We will briefly review the budget. Simone and I are developing a plan to purchase equipment and to do some environmental field testing.
- 6) For the Federal Funding Update. I will note that the Federal government cut approximately \$110 million in grants and funding from the MDPH. I have been told that we should be able to submit this year's training and certificate costs to the MDPH/Collaborative for payment. We may not be able to do the same in fiscal 2027. Three positions at the collaborative are in jeopardy. Our intern Danielle's stipend is in jeopardy. A Federal Judge has placed a stay on the grant and funding withdrawal. The MDPH will undoubtedly experience layoffs.
- 7) Simone and I met with Kristin at HR on Friday. We have several great candidates. Kristin is calling them today. Interviews will be scheduled this or next week.
