Generational smoking ban instituted

Restriction takes effect April 1

MANCHESTER-BY-THE-SEA — A “generational” smoking ban approved by the Board of Health is not sitting well with local retailers.

The board recently voted 3-1 to ban the sale of all tobacco and nicotine products, including cigarettes, e-cigarettes, cigars and chewing tobacco, to anyone born on or after Jan. 1, 2004.

“After discussion, the board voted to pass the local regulation with an implementation date of April 1, 2025,” said Wendy Hansbury, the town’s public health director. “This allows time for local businesses to pivot and educate staff.”

The ban is intended to curb smoking, Board of Health member Joan Cottler said.

“The hope is eventually (that) it will lead to people stopping smoking because they won’t be able to buy cigarettes because of their age,” she said. “All of us on the board feel it is detrimental to your health. We wanted to do what we could to help

Never attempt to influence

with limited energy stores. Do not feed wildlife. It is illegal and can make them sick, reduces their ability to hunt independently by creating a reliance on humans, and can result in the animal being euthanized if it becomes aggressive toward humans.

people stop smoking and better educate people about the problems with smoking."

The North Shore/Cape Ann Tobacco Policy Program will work with retailers to give them tools to deal with those who want cigarettes, but who are ineligible to buy them, Hansbury said.

"Pushback from customers could possibly be heated and/or dangerous to their employees," she said. "This is a serious concern; we encourage

preparation for it to anticipate problems and have ready responses available to employees."

"We want to be helpful to businesses implementing this locally as part of efforts to break the cycle of nicotine addiction," she said.

Hansbury, who is a registered nurse, said the regulation has enforcement and violation language "that is typical to tobacco regulations at the local and state level."

Stores in violation of the ban will face possible fines and suspensions of their tobacco

sales licenses.

The "Regulation Restricting the Sale of Tobacco Products" can be found at <https://manchester.ma.us/337/Board-of-Health>. It points to the ill-health effects of tobacco use, especially for younger users.

Store owners are calling on those who support civil liberties to join opposition to the ban, which they say is similar to a Brookline law recently upheld by the Massachusetts Supreme Judicial Court.

Reached by phone, Kevin Johnson, owner of Richdale Sub Express at 8 Beach St. in

Manchester, did not want to comment on the smoking initiative. Johnson said his shop sells cigarettes.

The influx of seasonal tourists will create challenges because of the patchwork adoption of the regulation in Massachusetts. Hansbury said a state bill adopted by the Legislature would help.

"I hope that retailers feel they can come to us and ask for help if needed," she said.

"We need to support their efforts as businesses and residents invested in our community.

"The board's choice to adopt this regulation is focused on changing the access points of a highly addictive substance. We are all interested in protecting each other from preventable disease."

The Stoughton-based New England Convenience Store & Energy Marketers Association (NECSEMA) said in a prepared statement it opposes the ban because its members contend the measure:

— "Haphazardly applies a discriminatory ban against the purchase of legal products" by legal adults, "treating

them differently from those before them."

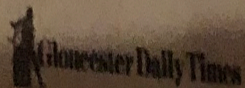
— Restricts "the free choices of legal products to adults," which they say is "fundamentally wrong."

— "Creates and supports a dangerous illicit market."

— "Does nothing to address under-age youth use of tobacco and nicotine products."

NECSEMA said it represents thousands of convenience stores in New England.

Hi Stephen,

Glad to answer, again thank you for your interest in our local public health efforts.

The Board vote was 3 to 1 to approve the Nicotine Free Generation section to be included in the Restricting the Sale of Tobacco Products Regulation. One seat is open. There are concerns from tobacco retailers and they did have opportunity to express their position at the public hearing.

After the meeting, I checked in with a long-time, local retailer/resident regarding the future impact of the change. We had a very good discussion about the meeting and the anticipated difficulties of implementing the age restriction at the checkout counter.

The retailer brought up valid concerns. The influx of seasonal tourists will create challenges because of the current patchwork adoption of the regulation; state adoption as proposed by the current legislature would help. Pushback from customers could possibly be heated and/or dangerous to their employees. This is a serious concern; we encourage preparation for it to anticipate problems and have ready responses available to employees.

My understanding is the North Shore / Cape Ann Tobacco Policy Program will work with retailers in the coming months to be ready by educating both the employees and the customers. The Board of Health wants to ensure that good tools are available to the retailers. I hope that retailers feel they can come to us and ask for help if needed.

They are a first line of public health protection measures by stopping the purchase of nicotine. We need to support their efforts as businesses and residents invested in our community. The Board's choice to adopt this regulation is focused on changing the access points of a highly addictive substance. We are all interested in protecting each other from preventable disease.

This is information I'm sure you have, but I've included as it is the main reasoning for the Board to adopt the Nicotine Free Generation regulation:

- "Tobacco product use remains the leading cause of preventable disease and death in the United States. In 2022, 49.2 million (19.8%)—or nearly 1 in 5—U.S. adults reported current tobacco product use.",
- "Youth and young adult use of tobacco products contributes to future use. This is because nicotine exposure can harm the developing brain and increase the risk for dependence.", and
- "Public health professionals and researchers have proven longstanding public health strategies can reduce tobacco use. These strategies include: Media campaigns, and Expanded access and availability of treatment and counseling for tobacco dependence.

These measures can be coordinated with tobacco prevention and control policies (e.g., price increases, smoke-free policies). Together, they are essential for reducing the toll caused by tobacco product use including disease and death in the United States."

Hello Stephen,

The Manchester-by-the-Sea Board of Health held a public hearing on November 12, 2024, to discuss the Tobacco Regulations including the 'Nicotine Free Generation' initiative. The ban is on the sale of products containing nicotine to people born after January 1, 2004.

After discussion, the Board voted to pass the local regulation with an implementation date of April 1, 2025. This allows time for local businesses to pivot and educate staff.

The regulation has enforcement and violation language that is typical to tobacco regulations at the local and state level. Both the Manchester Board of Health and the North Shore / Cape Ann Tobacco Policy Program emphasize education and prevention as we work cooperatively with retailers. We want to be helpful to businesses implementing this locally as part of efforts to break the cycle of nicotine addiction.
