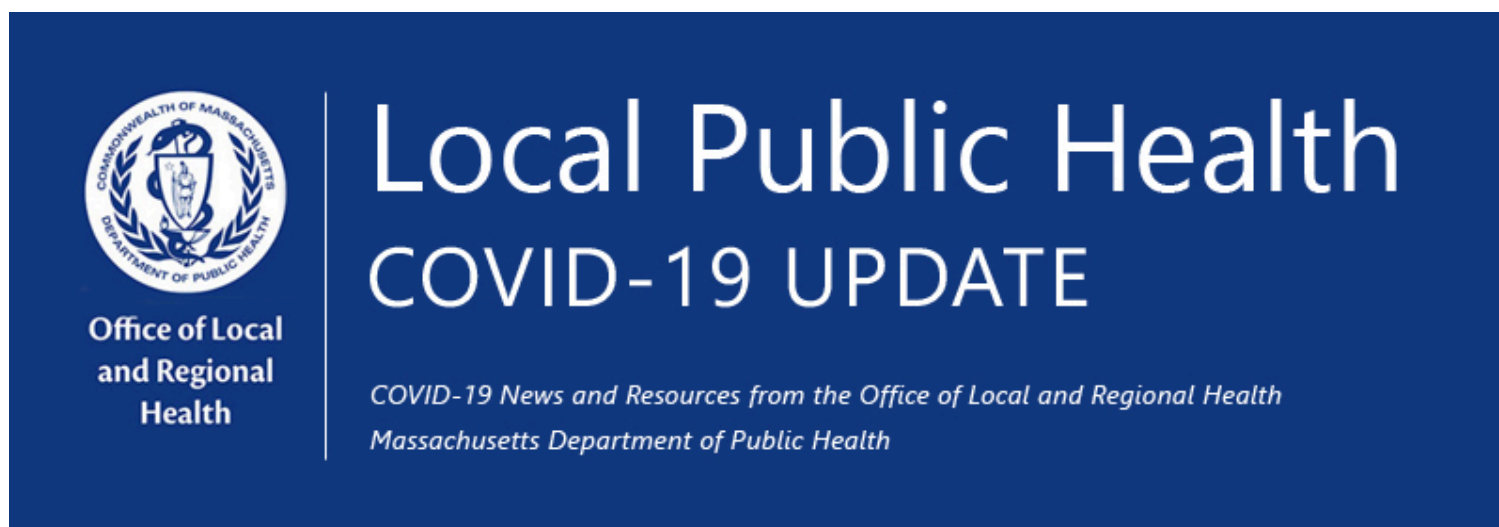

[Framework for Field Training Hubs](#)

The Special Commission on Local and Regional Health identified gaps in training and workforce development and recommended workforce standards. The existing training infrastructure which has gaps for competency development does include asynchronous self-paced training that allows for the attainment of basic knowledge for local public health work (tier 1) and classroom cohort-based training that allows for in depth knowledge-based competency (tier 2). Field training was identified by the Special Commission and local public health stakeholders as a major gap and critically needed for hands-on competency development. The 10 Field Training Hubs will address the need to provide field competency training, will build on the tier 1 and 2 training courses, the need for standardized training, the need for increased access to training to respond to turnover and aging out of staff, and the need to ensure that the local public health has the skills to meet the Performance Standards. The Field Training Hubs will provide hands on training to the Shared Services Arrangement (PHE grantees) public health workforce on housing, other Community Sanitation regulations, food protection and Title 5/wastewater/waste management. The Massachusetts Department of Public Health (MDPH) Bureau of Community Health and Prevention's Massachusetts Tobacco Cessation and Prevention program (MTCP) is issuing this Request for Response (RFR) to invite responses from qualified vendors to implement municipal tobacco and public health programming. Programs and strategies will support MTCP goals and priorities of reducing the prevalence of tobacco use, preventing youth initiation of tobacco use, reducing exposure to secondhand smoke, and eliminating tobacco-related inequities. This work supports MDPH's mission to prevent illness, injury, and premature death; assure access to high quality public health services; and promote wellness and health equity for all people in the Commonwealth.

All questions must be sent to mary.brush@mass.gov by February 27, 2023 by 3:00 PM EST. All questions received and their responses will be posted to Commbuys and can be accessed using the link above.

Applications must be submitted through Commbuys and are due by 3:00 PM EST on March 13, 2023. The Commbuys system time stamps each submission and the COMMBUYS system clock is considered the official time record. All applicants should allow adequate time for application submission. DPH is not responsible for delays encountered by bidders or their agents or for a bidder's local hardware (e.g., computer or network-related) failures associated with application assembly or submission.

Scholarship Opportunity for Local Health Department Staff to Become Certified in Infection Control - Applications Open

NACCHO, in partnership with CDC, is excited to offer a scholarship opportunity for local health department staff in obtaining certification in infection control (CIC) or a-IPC (Associate – Infection Prevention and Control) entry-level certification. NACCHO anticipates participation in this opportunity will increase the capacity of local health departments in infection prevention and control. Scholarship recipients will be reimbursed up to \$2,500 for exam fees and study materials (including books, membership fees, and/or training courses). Staff must register for the exam, and all reimbursable expenses must be incurred by June 30, 2023 (the exam itself can be taken after this date but needs to be within 90 days of CBIC confirmation of eligibility). Scholarship recipients will be expected to provide feedback on the certification process and demonstrate the impact of certification to NACCHO to inform future project activities supporting local health departments in infection prevention and control. More information about the exams, including eligibility requirements and guidelines for taking the exams, can be found on the Certification Board of Infection Control and Epidemiology, Inc.'s (CBIC®) website.

The deadline for submitting applications for scholarships is Friday, January 27 . On a rolling basis through Tuesday, February 2, NACCHO will select and notify LHDs for this scholarship. Reclaiming Native Psychological Brilliance 2023 Registration Information

United South and Eastern Tribes, Inc. would like to invite you and your staff to attend

the Reclaiming Native Psychological Brilliance: Wise Practices, a Tribal Behavioral Health ECHO, session titled Native Trauma and Healing: Releasing the Trauma Our Bodies Hold on February 28, 2023. Native Psychological Brilliance refers to the intelligence, strengths, balance, innate resources, and resilience of Native people. This no-cost telehealth series will be held throughout 2023 on the fourth Tuesday of every month at 11:00 am Pacific/12:00 pm Mountain/1:00 pm Central/2:00 pm Eastern. Each session will be one hour in length that will provide an opportunity for participants to:

- Increase knowledge of innate intelligence and resilience of Native people which can assist in trauma recovery
- Increase understanding of how trauma can change brain functioning, contributing to hyper alert status and emotional dysregulation
- Learn ways to expand trauma response beyond conventional treatment of PTSD symptom reduction and psychotropic drug prescription
- Gain knowledge of how Native traditions (dance, movement, etc.) can assist with trauma recovery, self-regulation, cultural-self empowerment, and whole-person treatment

Who should attend? Tribal Nation health directors, clinic staff, counselors, social workers, physicians, nurses, Tribal Epidemiology Center staff, and anyone supporting Tribal Nation citizens through the health/behavioral health sector are welcome to join.
