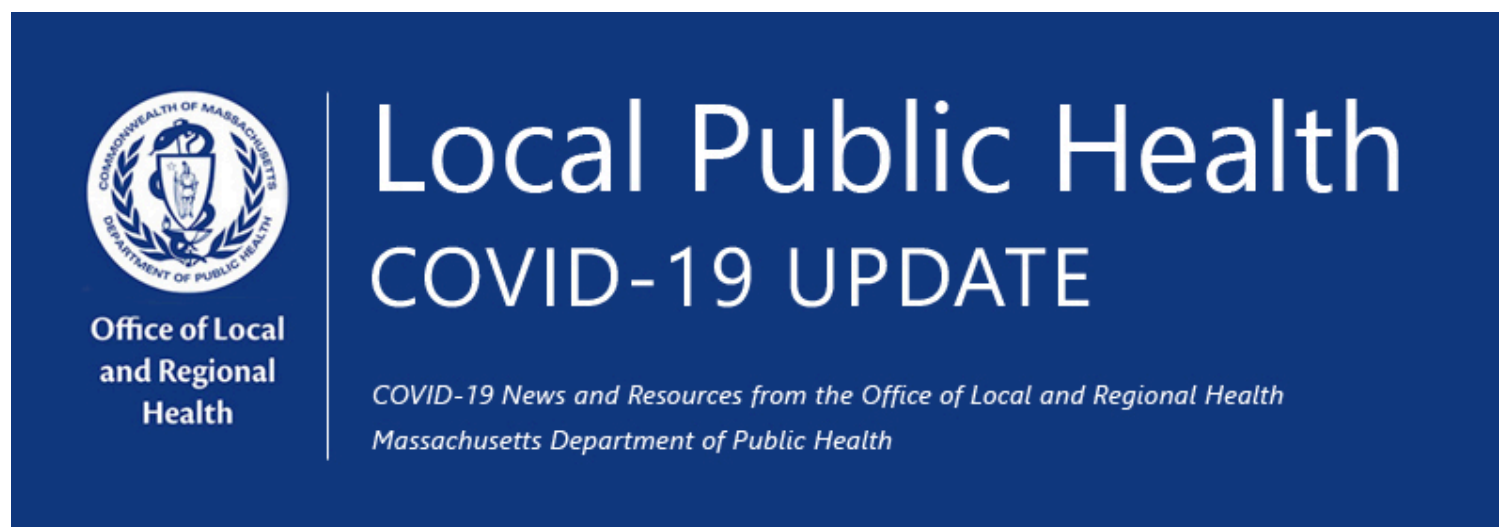

Extra COVID Food Funds for Families Ending March 2

Extra COVID Supplemental Nutrition Assistance Program (SNAP) benefits, known as SNAP Emergency Allotments, were created during the pandemic to help individuals and families buy food. These extra COVID benefits are the difference between a household's normal benefit amount and the maximum amount for their household size, with a minimum amount of \$95 a month. The benefits have been put on EBT cards at the beginning of each month. Since March 2020, Massachusetts has elected to utilize this temporary benefit program made available under the Families First Coronavirus Relief Act.

Recent action by the federal government (through the Congressional Consolidated Appropriations Act 2023) ends the extra COVID SNAP benefits as of February 2023. This means that Massachusetts households will receive their last extra COVID SNAP payment on March 2, 2023.

The state has launched a new website: Mass.gov/ExtraCOVIDSNAP, to help residents plan for the end of these temporary federal benefits. Over the next several months, individuals and families should explore any optional expenses that may increase their normal SNAP benefits.

FDA Alert-REcall of " Deep Bay Cream" due to possible lead contamination

Last week CLPPP put out an important Diep Bao Cream recall announcement. I am reaching out to colleagues across DPH and beyond to help spread the word. The Vietnamese version of this document is attached.

- On February 1st, 2023, Shop Me Ca of Herndon, VA announced a voluntary recall of its 10-gram tubes of "Diep Bao Cream" because they have the potential to be contaminated with lead.
- Diep Bao Cream was sold nationwide through Shop Me Ca's Facebook page and a Vietnamese Moms' Facebook groups: Hội Mẹ Việt Nuôi con Tại Mỹ, Mẹ Việt Tại Mỹ, Chuyên Đồ Bầu và Chăm Sóc Sau Sinh, and Nguyễn Ngọc.
- Customers who have purchased 10-gram tubes of "Diep Bao Cream" should immediately discontinue use of the product and dispose of it immediately .
- The Massachusetts Department of Public Health is currently investigating a poisoned child case where Diep Bao Cream was identified as a potential exposure source.
- Children are particularly vulnerable to lead exposure. Lead in children can harm their brain, kidneys, and nervous system, slow growth and development, make it hard to learn, damage hearing and speech and cause behavior problems.
- A blood lead test is the only way to know if you or your child have been exposed to lead. Talk to your doctor about getting tested.

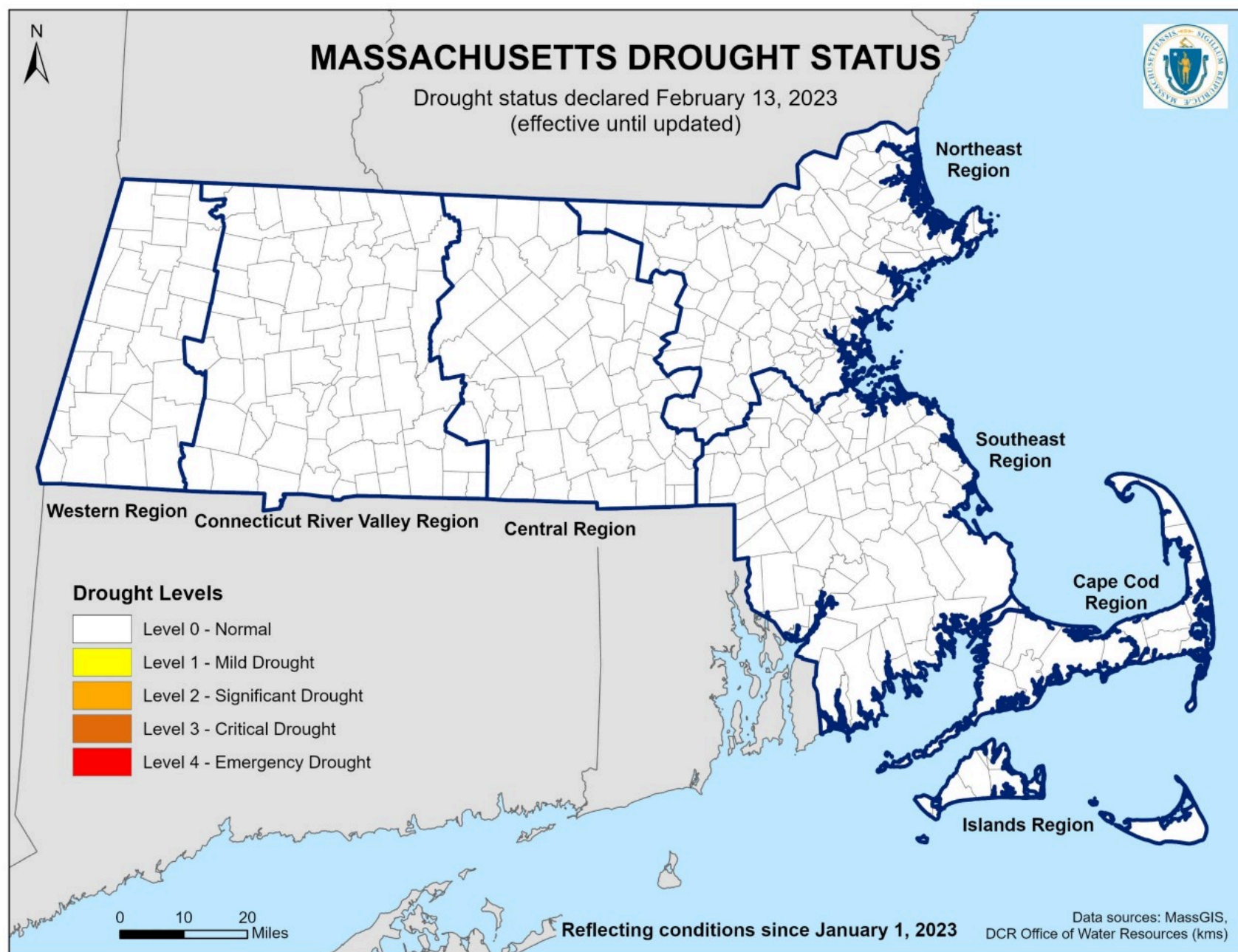
The Massachusetts Department of Public Health (MDPH) Bureau of Community Health and Prevention's Massachusetts Tobacco Cessation and Prevention program (MTCP) is issuing this Request for Response (RFR) to invite responses from qualified vendors to implement municipal tobacco and public health programming. Programs and strategies will support MTCP goals and priorities of reducing the prevalence of tobacco use, preventing youth initiation of tobacco use, reducing exposure to secondhand smoke, and eliminating tobacco-related inequities. This work supports MDPH's mission to prevent illness, injury, and premature death; assure access to high quality public health services; and promote wellness and health equity for all people in the Commonwealth.

All questions must be sent to mary.brush@mass.gov by February 27, 2023 by 3:00 PM EST. All questions received and their responses will be posted to Commbuys and can be accessed using the link above.

Applications must be submitted through Commbuys and are due by 3:00 PM EST on March 13, 2023. The Commbuys system time stamps each submission and the COMMBUYS system clock is considered the official time record. All applicants should allow adequate time for application submission. DPH is not responsible for delays encountered by bidders or their agents or for a bidder's local hardware (e.g., computer or network-related) failures associated with application assembly or submission.
