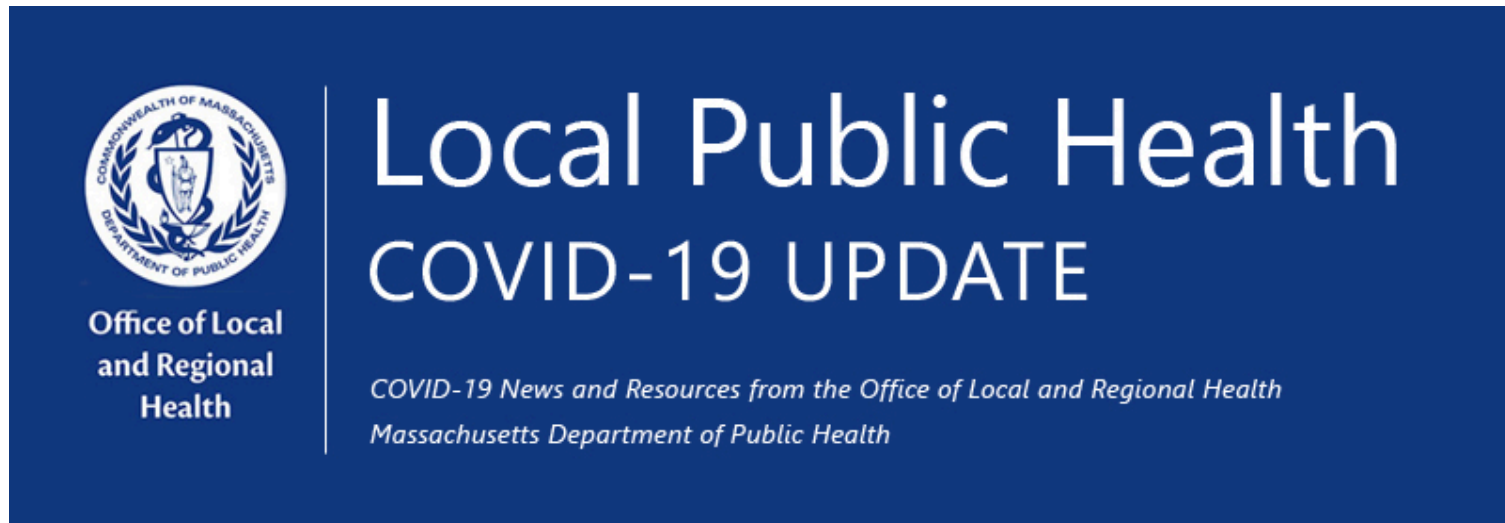

Massachusetts Statewide Opioid Settlement Funds- AGO/DPH Virtual Forum

The Attorney General's Office and the Department of Public Health's Bureau of Substance Addiction Services and Office of Local and Regional Health will hold a virtual forum about the statewide opioid settlements on **Tuesday, March 7 at 3:00 - 4:30 PM ET**.

The forum will provide information about five new proposed settlements with Allergan, Teva, Walmart, CVS, and Walgreens, including information on what municipalities need to do to sign on to these settlements by the April 18, 2023, deadline.

Attendees will learn about the settlement participation process, details about the abatement funds that will be available to participating municipalities from these new settlements, and strategies for community engagement in the use of opioid settlement funds. There will also be an opportunity to ask questions.

Massachusetts Department of Transitional Assistance

As you are aware, during the pandemic extra Supplemental Nutrition Assistance Program (SNAP) benefits have been available each month to help families buy food (minimum of extra \$95/month per household). [Due to recent action by the federal government, these benefits are ending February 2023](#). This means that over 640,000 households in Massachusetts will receive their last extra federal SNAP payment next Thursday March 2, 2023.

[New Public Health Scholarship Program Focuses on Next Generation of Rural Health Leaders](#)

Apply by August 13

The Rural Health Innovation Program at Berkley Public Health will offer 100 fully paid scholarships to eligible online students seeking a Master's in Public Health to support leadership development for rural public health leaders. The program, with backing from the [Barr-Campbell Foundation](#), was announced at the recent National Rural Health Association Policy Institute and will also cover other expenses such as books, fees, and travel expenses. Within that cohort, the program will also support 10 scholars with an interest in activating change to focus on rural policy efforts.

Due to the ending of the pandemic public health emergency, MassHealth will soon return to standard annual eligibility renewal processes. Over the coming year, all current MassHealth members will need to renew their information to ensure they still qualify for their current MassHealth coverage. These renewals will take place over 12 months. MassHealth is working with its partners to make sure members know how to renew their coverage and are aware of other affordable health coverage options if needed.
