On Monday, [FDA approved and authorized updated COVID-19 vaccines](#), and on Tuesday, CDC's Advisory Committee on Immunization Practices [recommended the updated vaccines](#) for everyone 6 months and older. The updated COVID vaccines, which are covered without cost sharing by all insurance providers, began shipping Tuesday night and will be available in clinics, at pharmacies, and through local health departments as early as the end of this week.
