TRAIN MA Learning Management System Implementation

TRAIN Massachusetts is live!

TRAIN Massachusetts (TRAIN MA) is now available to all local public health professionals in Massachusetts.

What is TRAIN MA ?

TRAIN MA is an online learning management system which provides quality training opportunities for professionals who protect and improve the public's health. TRAIN MA will be replacing the Local Public Health Institute hosted by Boston University (BU/LPHI). The LPHI course catalog, which is currently hosted and managed by BU/LPHI, will be migrated to TRAIN MA.

Reminder to Save Your BU/LPHI Transcript

You will have full access to your course transcript and completion certificates on LPHI through March 31, 2024. We highly recommend you download and save all your LPHI transcripts and course completion certificates by March 31, 2024 for any future reference. This proactive step will ensure your professional achievements remain easily accessible to you. While BU-LPHI and OLRH will retain course records following all pursuant course provider regulations as outlined in state guidelines, please be aware you will no longer have access to your course transcript or completion certificates through BU/LPHI after March 31, 2024.

Apply for the Municipal Master Services Agreement (MSA) RFR

The purpose of this [Request for Responses \(RFR\)](#) is to establish a pre-qualified list of approved vendors, namely local and regional public health entities, to be eligible for potential future funding from the Department of Public Health DPH. This approach will provide a simplified process for eligible entities to access DPH funding, consolidate multiple sources of funding from DPH, and create a more efficient process for how certain funding is distributed.

All municipalities, regional planning agencies, regional council of governments, or regional health districts are strongly encouraged to apply as many future DPH grants will be distributed through this municipal master services agreement (MSA).

NOTE: PHE lead grantees are already in the MSA and do not need to apply.
