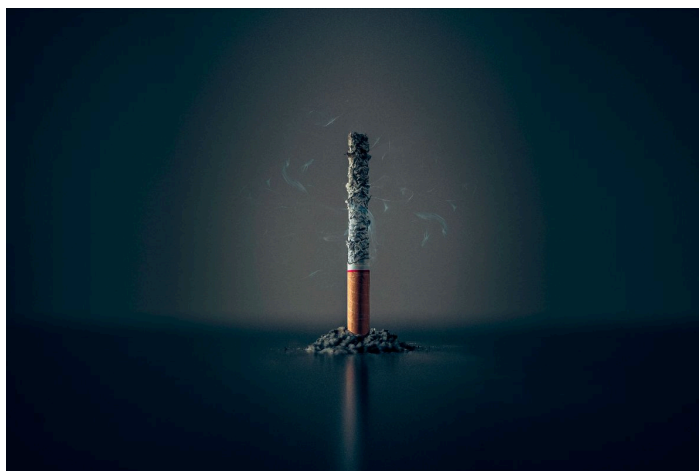
## Hemp Derived CBD and THC Not Allowed in Food and Beverages Manufactured or Sold in Massachusetts



The Massachusetts Department of Public Health (DPH) and the Massachusetts Department of Agricultural Resources (MDAR) issued the following [Frequently Asked Questions](#) document to make clear that addition of CBD and/or THC to food manufactured or sold in Massachusetts is illegal. This does not apply to edible marijuana products licensed and sold under the jurisdiction of the Cannabis Control Commission.

## Implementation of Flavored Tobacco Products Regulation

The Massachusetts Department of Public Health (DPH) understands that there is confusion from both tobacco retailers and local boards of health about whether tobacco products labeled as non-menthol tobacco products but marketed to menthol consumers constitute a flavored tobacco product within the meaning of [Massachusetts General Law, Chapter 270, Section 28](#) and the Department's regulation [105 CMR 665.000](#).



Please read the following [DPH advisory](#) for clarification on flavored tobacco products. Retail establishments that are not licensed smoking bars should remove these products from their premises no later than 30 days after this release (July 6, 2024).

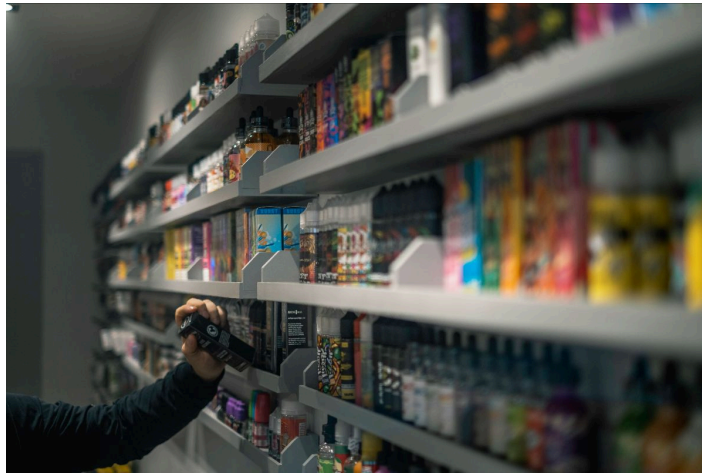
### Registered Environmental Health Specialist / Registered Sanitarian (REHS /RS) Study Courses Available

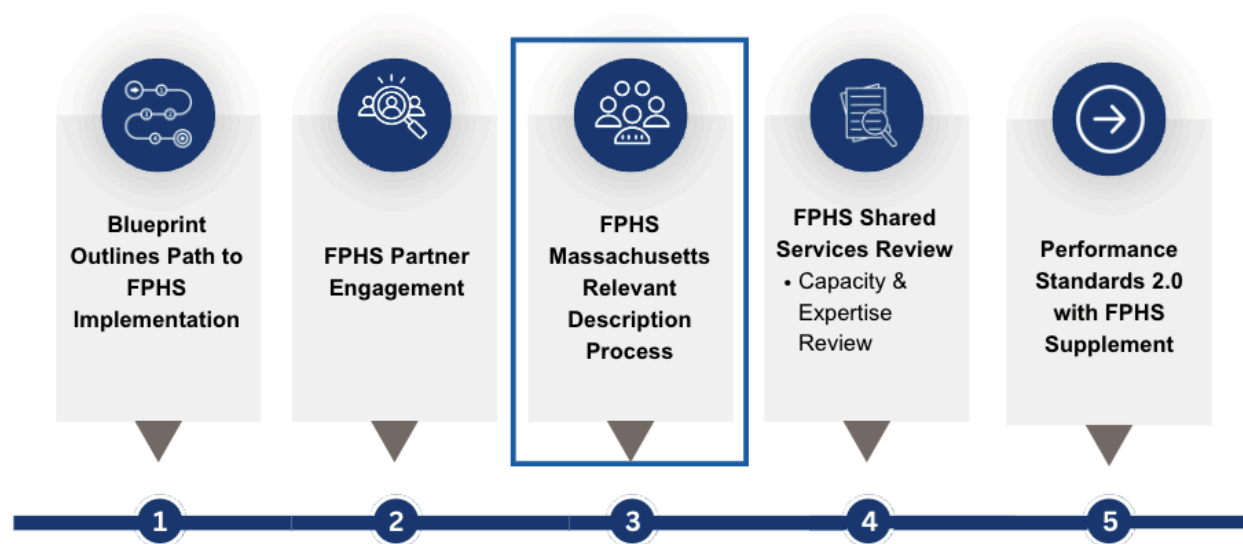

## Engaging LPH in Adapting the FPHS for Massachusetts

OLRH is excited to share updates about our journey towards adapting the Foundational Public Health Services (FPHS) Framework for Massachusetts Local Public Health. The Massachusetts Relevant Description Process begins in early June and marks an important milestone in this journey. OLRH led a peer nomination process with local public health and partner organizations to solicit nominations for Foundational Advisory Team Members and the Steering Committee who will champion the Massachusetts Relevant Description Process. To ensure a commitment to advocating for the needs of communities across Massachusetts, all of the Steering Committee members represent local public health.

### Next Steps

Foundational Advisory Team members will review assigned [FPHS Framework language](#) and suggest terminology and examples to best align with Massachusetts local public health infrastructure. This collaborative effort will help ensure the FPHS accurately reflects local public health needs and priorities for Massachusetts' diverse landscape. This process will lead to a Capacity and Expertise Review at the Shared Services Arrangement-level in early 2025 for those municipalities participating in the PHE grant program. Throughout this process, OLRH will work with local public health and PHE Grantees to ensure they are informed and supported.

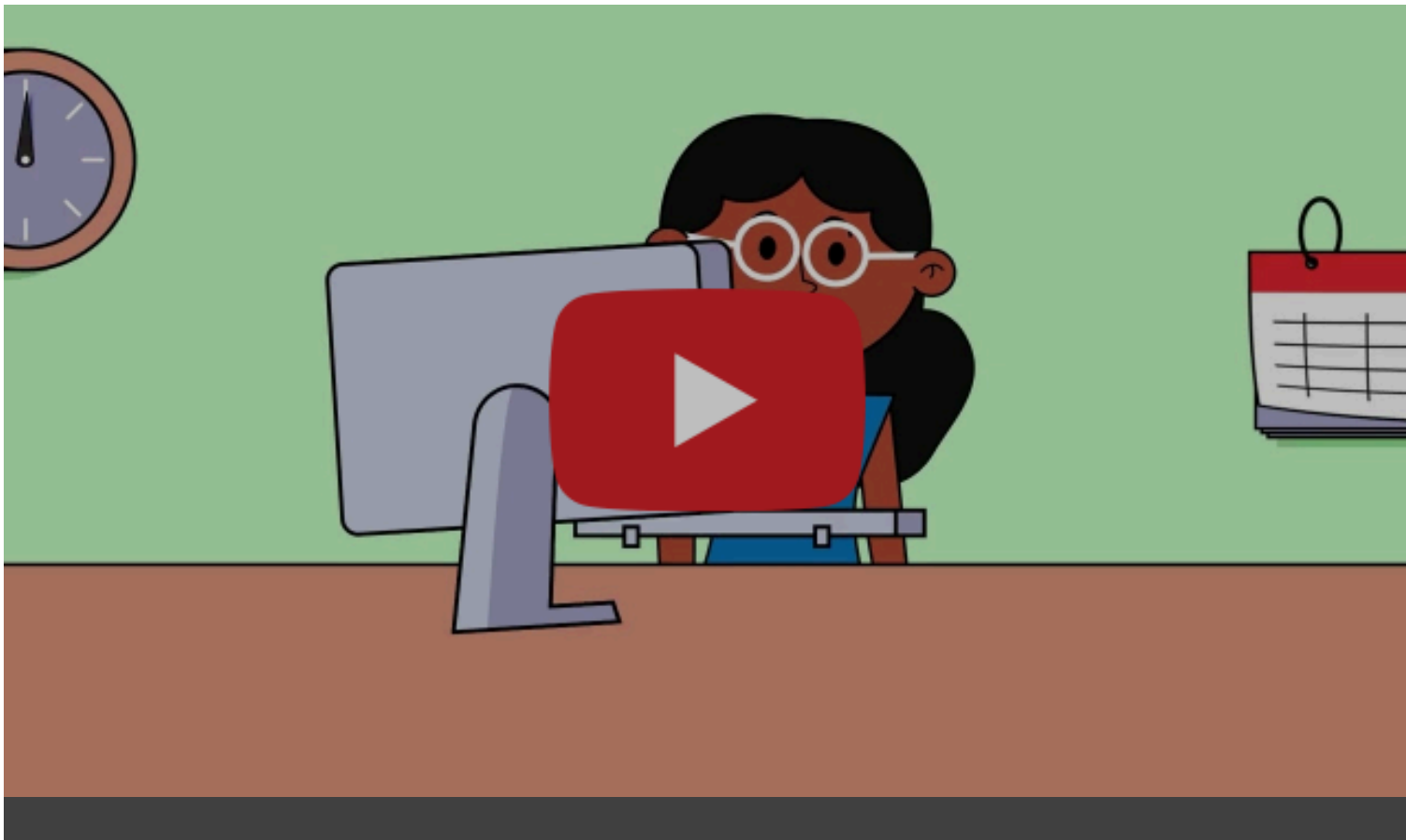
