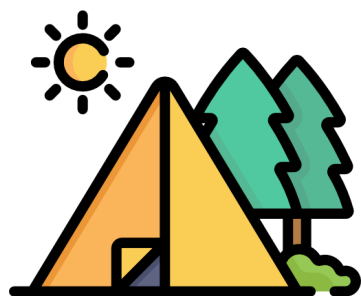

While the recreational camp information is still fresh in your minds, please take a moment to complete the electronic [Recreational Camps for Children Reporting Form](#) to comply with 105 CMR 430.632, which requires that LPH notify the Massachusetts Department of Public Health of all licenses issued to recreational camps within their community.



This form is also to be used to report if no recreational camps were licensed in your city /town. The Department no longer collects written or faxed forms. If you would like a full copy of the information reported once the form has been submitted, please email recreationalcamps@mass.gov and a full PDF copy will be sent to you.

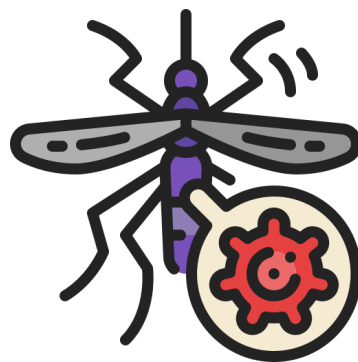

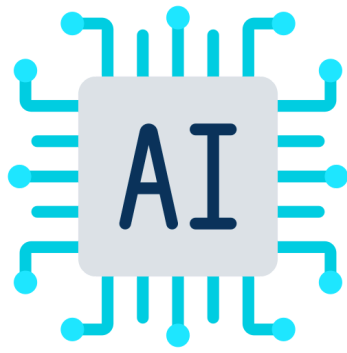

All municipalities and/or regional health districts are strongly encouraged to apply as many future DPH grants will be distributed through this municipal master services agreement (MSA). **NOTE:** PHE lead grantees are already in the MSA and do not need to apply.
