Hello Dr. Hartford,

Hope you don't mind me writing to you. When I saw your response to Tamu's request I couldn't help but think you would be a great addition to the all-volunteer group that is working hard to spread NFG (Nicotine Free Generation) across the state. There are currently 17 Massachusetts municipalities that have NFG in place - - most by Board of Health regulation - - and more than 500,000 MA residents live in a municipality that has adopted NFG.

Our goal is to continue adding cities and towns, one by one, Board by Board, until we have critical mass which will make it more likely that the state legislature will pass NFG state-wide as they did for Smoke-Free Workplace Law, T-21, and the flavor ban.

Please let me know if you are interested in speaking more about this. Or if I can send you additional information. Or if you just want to be added to our email distribution list which means you would receive our updates (Board meeting in Leveritt tonight for instance) and the notices of our (sort of) bi-weekly Zoom meetings - - usually on a Monday evening at 6:00 PM.
