I'm sure you are very well aware but I wanted to make sure you saw the news.

Three state legislators announced last Monday at the Nicotine Free Generation Celebration at the State House that they will be filing NFG legislation in January.

Extremely heavy lift for the state so we will continue to work at the local level because we know new youth get addicted every single day. And becoming addicted, especially at a young age, can mean a life-time of nicotine use with significant financial and health consequences. And as Anthony Ishak pointed out at Chelsea's recent public hearing, additional opportunity costs. Nicotine users cannot join the military or become police officers or firefighters. I don't want to see more youth suffer the unanticipated burdens of nicotine addiction. Not even one.
