Hi all —

I just had a 30-minute conversation with Gary Hunt, NR BOH chair, regarding the possibility of holding a joint public hearing on NFG.

Important outcomes/info:

— There is a BOH meeting tomorrow night (6/17) at 7 p.m. There will be an NFG update toward the end of the meeting from the public health nurse. Gary said he would allow comments during that discussion. I'm not sure if we can get enough people to log in between now and tomorrow, but here is the link with the log in and

— Gary said the entire BOH will need to decide, but he is, at this moment, **firmly of the mind** to take this to Town Meeting. He said he has not heard from enough townspeople in favor of NFG for the BOH to take it up; there is a minuscule chance we could change his mind, but the notice is too short to get a critical mass to the meeting tomorrow night. He did say that the BOH would co-sponsor the article and could take it up as a regulation if it failed at TM. I gave my best pitch that this not the best order, but he wasn't budging.

— We can talk about how he needs to hear from townspeople to help convince the BOH otherwise on the approach. (For one, he needs a critical mass of PERSONAL e-mails, not formulaic.)

Jen — Is it possible for you to do an e-mail to Coalition members tomorrow encouraging them to attend the BOH meeting tomorrow night? If not, I can do it.

There's much more to say, but I'll leave it at that.
