MHOA is in the process of updating its Roster of Health Departments a Public Health in Massachusetts.

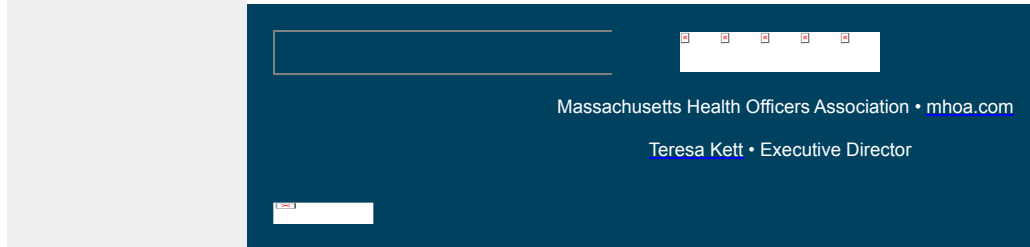
The newly revised roster will contain approximately 60 pages of information booklet and will be distributed to local health officials attending MI
