Sure.

It was a pretty comprehensive report that all this very, very active coalition is doing – much of it around non-tobacco substance use prevention and treatment. I did a one-minute update at the end. Just stated that eleven communities adopted NFG in 2024, with three municipalities doing so in December. We now have twelve total. Working to get many more so that it makes it more likely that state legislators will pass a state-wide bill. Bill language being worked on right now by Senator Lewis and State Rep Vitolo's offices as we speak. And that I am presenting to Pittsfield BOH tomorrow evening. That's it - just a one-way report. I didn't ask for anything.

There are a lot of community events coming up. You might want to reach out directly to the Coalition and offer your services/assistance. Not sure there are any events at which you could table and provide vaping cessation and other info. Parent university is going to be virtual this year so no way to connect with folks as they enter and exit a building which has been somewhat successful in the past.

Three folks have been certified to teach Catch My Breath. That's great news! They are rocking!
