I'm so sorry for the slow reply - I'm on my sub-i this month so a bit busier than typical. That approach sounds great. I was hoping to get at least 1 attempt out to every town for now, in hopes of getting as close to a true cross-section as possible, and will then circle back with further outreach attempts. So far, 100 towns have been contacted with 19

responses. I was planning to send out a large wave this week of ~75 more towns.

I would also like to really highlight Daniel's phenomenal efforts (in addition to the tremendous efforts of the whole team) in gathering email contacts. He has done a terrific job of identifying contacts that I would have never found and it has significantly helped the response rate.
